
Emergency Action Plan for Man Overboard or Life Threatening Injury – Steps:

- Render assistance & make contact with other Skippers on scene
- Call 911 & VHF 16 for Help & Emergency Medical Attention:
 - US Coast Guard Sector Baltimore: VHF #16 and 410-576-2525
 - MD DNR: 410-260-8888
- Monitor and administer first-aid: (Boats with AED, EMT's, Physicians)
- Transfer: Where do you plan to bring the injured person ashore for Transfer to EMT's (See Chart). Send someone off the boat to meet/direct Emergency vehicles
- **Debrief and inform key people:** Commodore, Rear Commodore, and the Family of injured. MD-DNR incident report with the authorities.

Stay Calm & Communicate clearly and be prepared to tell 9-1-1, MD-DNR & the US Coast Guard the following:

- Who: You must identify yourself by boat name and Digital Selective Call sign if you have one.
- Where: Clearly state your location as accurately as possible. This can be GPS coordinates (most important); landmass sightings; your distance to shore or a Navigation Aid: Day mark, light or buoy. Latitude & Longitude off of your GPS Unit or use the MRSA Race Mark Tables Lat. and Long.
- What: Explain the type of emergency you are experiencing (e.g., Man-Over-Board; the boat is taking on water or is beginning to sink; a passenger is suffering a heart attack; there is a fire aboard).
- **Kind:** State the nature of assistance you require MOB, EMT, SINKING VESSEL or FIRE (e.g., we need water pumps; a doctor or medic is needed; requesting immediate rescue).
- **Number:** Give the number of souls on board and their condition, if hurt or injured.
- **Description:** Describe your boat in detail (boat type, manufacturer, superstructure, color, striping, any distinguishing features or markings to help quickly identify your boat).
- When: Time of incident, wind direction and Current for SAR: Search and Rescue

EMERGENCY RADIO PROCEDURES

Speak SLOWLY, CLEARLY, & CALMLY

- 1. Make sure the communication equipment is ON.
- 2. Select VHF Channel 16, 2182 KHz, or other emergency frequency used where you

operate.

- 3. Press microphone button and calmly say, "MAYDAY MAYDAY MAYDAY This is
- S/V_____, S/V______, S/V______. Over."
- 4. Release the microphone button briefly, and wait for an acknowledgement. If no answer,

repeat Step 3.

5. If still no answer, or if the Coast Guard or another vessel responds, say,

"MAYDAY, This is S/V_____"

6. State Your Location Twice (latitude & longitude, GPS, or range & bearing from a

known point such as a MRSA Race Mark)

- 7. State the Nature of Your Distress
- 8. State the Number of People On Board and the Number of Injuries, if any
- 9. State Condition of Vessel
- 10. Describe vessel. Length: _____ft. Hull Material: _____ Color:
- *11. Describe lifesaving equipment:*

Survival Craft: ______ Immersion Suits: _____ EPIRB: _____

- 12. Say, "I will be listening on VHF Channel 16/2182 (or other channel being monitored)."
- 13. End by saying, "This is S/V______."
- 14. If the situation permits, stand by the radio for further communication with the Coast

Guard or another vessel. If no one answers, repeat the above, then try on another channel.
